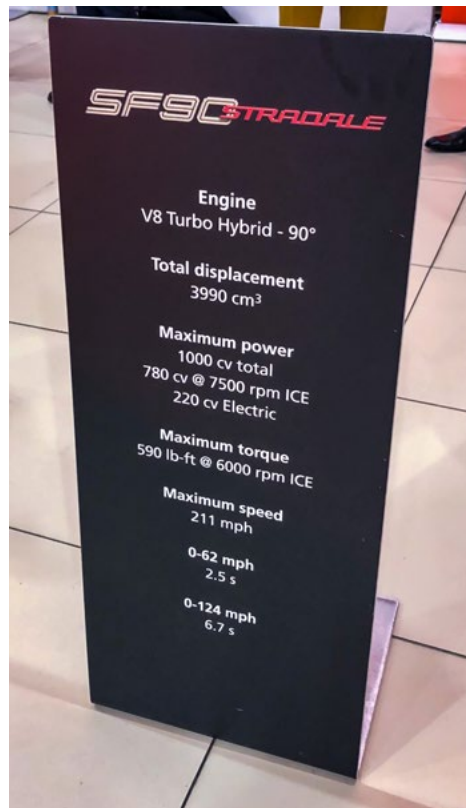

The Concours weekend will begin on Saturday night July 11th at the renovated 'Red Lion on the River' hotel, for an outdoor reception. There are a group of rooms available for a limited time at, <https://book.passkey.com/go/FCofA2020>, or call 503-283-4466.

The Concours will be held the next day, Sunday the 12th at the same location as last year, Columbia Edgewater CC. We expect to have over 85 cars on the field.

Due to limited parking, attendance again will consist of NWR members, their guests, and CECC members and their guests. Even with this restriction we still had over 400 people in attendance last year, and expect more this year.

After last years' event we did a full analysis of the weekend and will be making a few changes to improve the experience for everyone.

The luncheon at the Club will be upgraded and there will be more chairs, tables and tents for our sponsors and the attendees to use. We have made other changes to the event, which should make it run smoother and be more enjoyable.

Organized drives have become very

This Summer's Concoors Drives: In Preparation for the FCA 2021 Annual Experience Drives

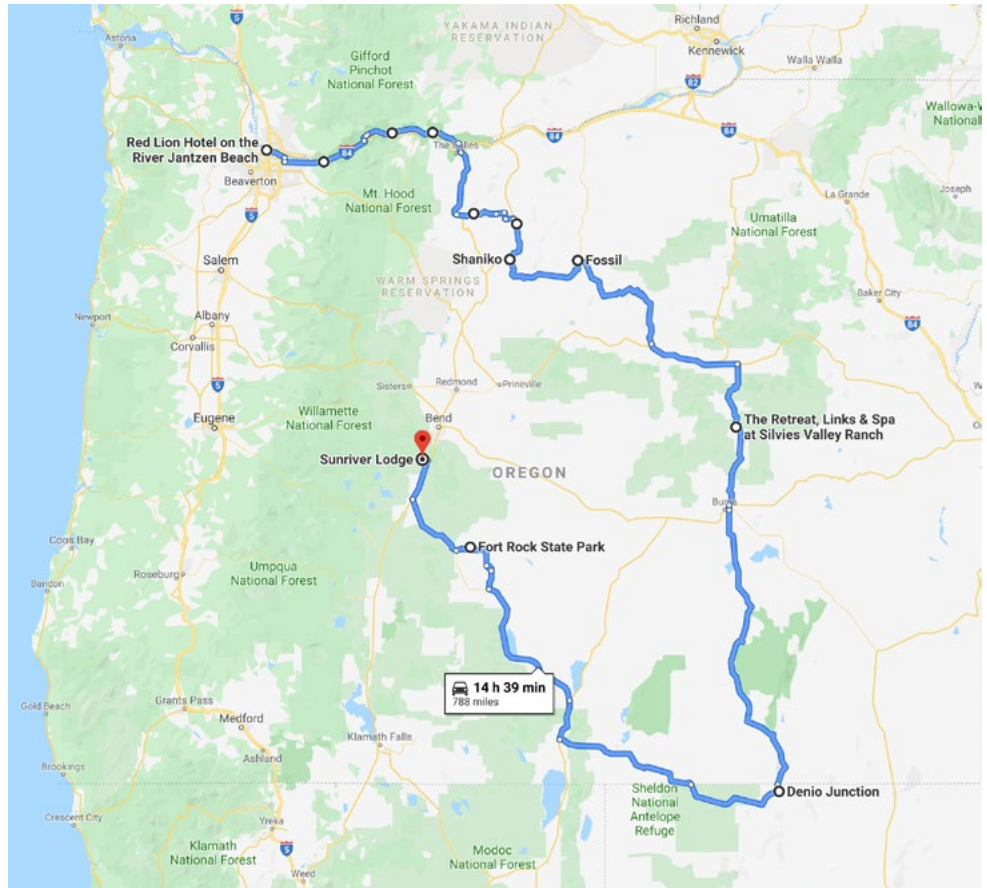
As an extra incentive for FCA members from around the country to join us here in the Pacific Northwest for the FCA 2021 Annual Experience—and to provide them a compelling reason to bring their Ferraris—we plan to host four 3-day driving tours around different regions of the beautiful state of Oregon. These drives will take place immediately following the four days of the Annual Experience: The High Desert Tour, The Crater Lake Tour, The Oregon Coast Tour and the Bandon Dunes Golf Tour.

As part of our planning and preparation, we will be doing trial runs of the first three of these tours this summer; the route to Bandon Dunes is already well known to us.

These 3-day test drives will be run immediately following this summer's 12 July NWRFCA 2020 Concoors d'Elegance, held at the Columbia Edgewater Country Club in Portland. Each drive will leave from the newly renovated Red Lion Hotel on The River, the morning of Monday, 13 July. Our goal in doing these drives this summer is to sort out the final driving routes/stops/meals and to introduce interested and willing NWRFCA members to the ins and outs of being group leaders (of whom we will need many) for the actual 2021 tours. Of course we will also have a lot of fun and get to know our other NWRFCA members.

All NWR members are invited to be a part of one of these three groups, whether you are interested in being a 2021 tour leader or not.

Because we are planning for three different groups this summer, and because this is peak season we will not be making group bookings. The savings was about \$10 a night and some



places required full payment at the time of making the booking. Therefore you need to book your own lodgings for the drive you choose. In order to ensure you get a room it would be better to book now and if necessary cancel later, as opposed to waiting to make the reservation. Of course you can use the hotels' individual cancellation provisions, so you won't be on the hook, should you need to cancel. Also if you cancel we might be able to transfer your reservation to someone who tried to book too late. Our job will be to manage any canceled rooms from those who have registered, for the drivers who decided too late to get a room. For instance Sunriver Resort only has 20 rooms available for our night there. We need you to book both your rooms ASAP, hopefully no later than 1 February 2020!!!

Below are the planned drives with the dates and hotels we need you to reserve for the tour you choose:

The High Desert Tour, led by Erik Swensson, emphasizes the open-road driving experience and features many great roads, little traffic vast expanses of scenery and a lot of entertaining miles. This is for the drivers in the NWRFCA. (See map above.)

Monday, 13 July: We will stay at Silvies Valley Ranch, 800-745-8437. Talk to Marissa Clark, the reservations manager. Single king bedrooms are \$329, \$349 with a view. The rooms with two king beds are \$369 or \$389 with a view. This room can be shared with two people. Two couples can share a cabin with two separate rooms with a king bed each and bath suites for \$849. Dinner at the ranch is a set price at \$55.

Reserve now through mid-February and there is no cancellation charge up to 60 days in advance:

Tuesday, 14 July: We will stay at Sunriver Resort, 855-420-8206. Talk to Kelly Cooper for individual room reservations. Their basic room is two full-size beds at \$350.94 that are 330 sq ft, and two queen beds at \$375.96 that are 487 sq ft. Dinner will be at a local restaurant nearby TBD. This resort is already tight on rooms with only 20 left. So be sure to book this lodging ASAP. Cancellation lead-time at no charge is 21 days:

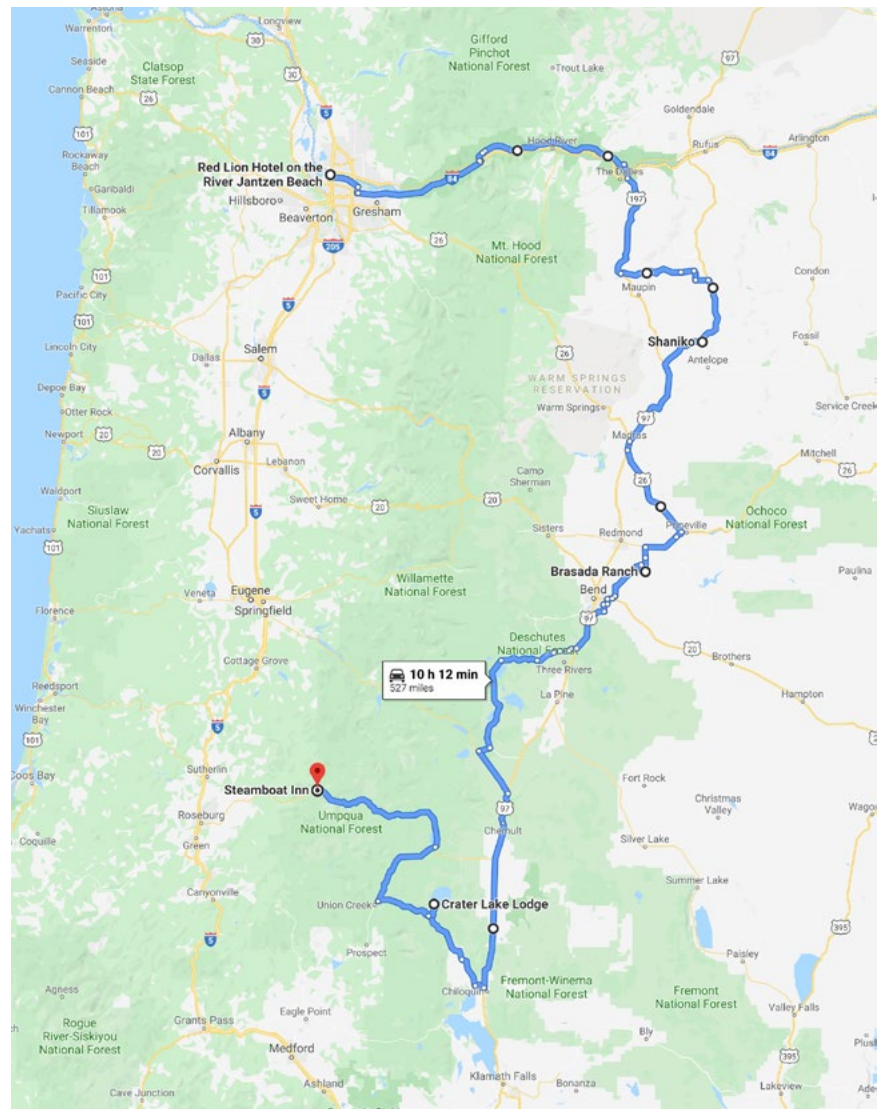

The Crater Lake Tour, led by Dave Tegeler, will include a mix of great driving roads, some traffic, much spectacular scenery, a hike to the shore at Crater Lake, and a run out to the Oregon Coast for a few miles of beach. (see map)

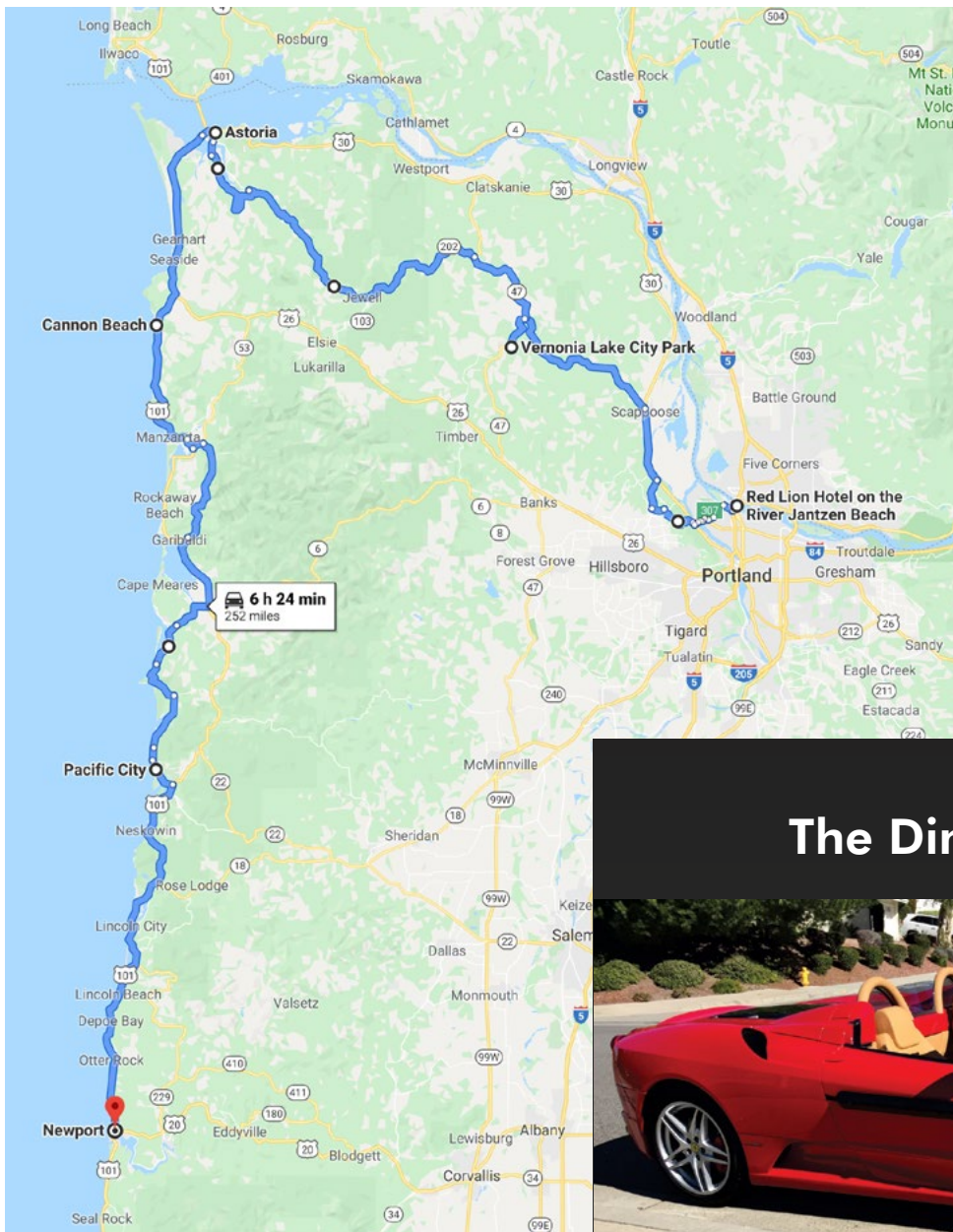
Monday, 13 July: We will stay at Brasada Ranch, 866-373-4882. Talk with Whitney Nelson. Rates in the hotel portion is \$493.97 with all fees and taxes included for the basic room, \$543.49 for the upgraded room. They have two bedroom Cabins that if both bedrooms are rented run \$395 per room, all in. So best to find a couple or someone to take a room and rent

both cabin bedrooms. Cancellation fee is \$35 down to a lead-time of 30 days. Best plan is to reserve the cabin and let Dave Tegeler (425-432-2800 – davetegeler@gmail.com) know you need another couple to share a cabin or contact him first to see if there is a cabin room already available.

Tuesday, 14 July: We will stay at Steamboat Inn, 541-498-2230. Rates are \$355 for a suite and \$215 for one of the cabins on the river (highly recommended). Cancellation requires a 30-day lead-time with a 10% charge (if they subsequently book the room the 10% charge is refunded).

The Oregon Coast Tour, led by Steve Bledsoe, will take snaking driving roads from Portland over the Coastal Range for an afternoon in Astoria, then many leisurely stops along the coast on our way to Cannon Beach.

Then on Tuesday we make our way to Newport for meals with views and plenty of sightseeing opportunities along the way.

Our emphasis will be on showing our out-of-town guests as many of the features of the northern/central Oregon Coast as we can in two days. (See map above)

Monday, 14 July: We will stay at the Hallmark Resort & Spa Cannon Beach,

503-436-1566. Rates range from \$249 for a non-view king room to \$409 for an oceanfront king with spa; 48-hour cancellation.

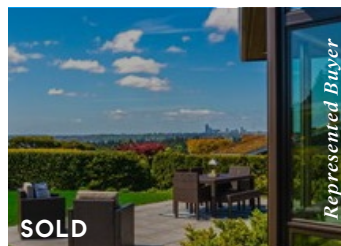

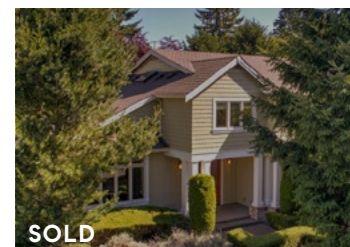

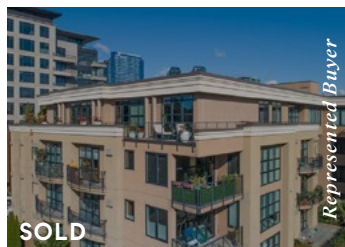
